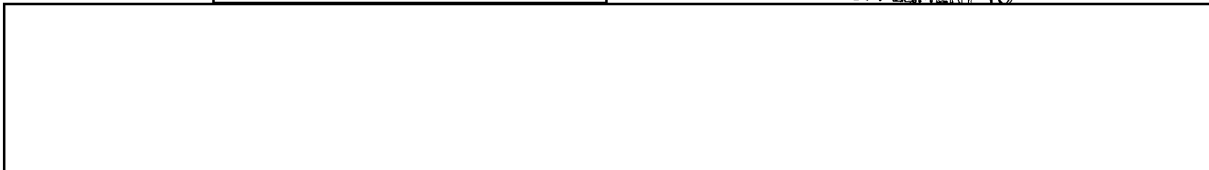

- Location: In the northeastern sector of SERPUKHOV (37°29'E/75°45'N), east of the road to MOSCOW. The RR line to MOSCOW is a little farther to the east.
- Plant installations: The plant covered a site of 1,000 x 650 feet. A building, 500 x 50 feet, with a transformer station on the ground floor and a laths department and magazines on the upper floor, was located on the western side of the plant area. Another building on the southern side, 660 x 65 feet, had storage rooms on the ground floor and dormitories for workers and guards on the upper floor. A third building, used as an assembly hall, 165 x 33 feet, was located in the northern section of the area. Four test stands were located in the eastern plant section.
- Work force: Five hundred Soviets and about one hundred PWs worked in day shifts only.
- Production: Spare parts for aircraft engines. Complete engines, 14-cylinder double-row radial engines, which were shipped to the plant, were overhauled and repaired and then shipped out by rail or truck.
- Transportation facilities: There was a spur track from the SERPUKHOV main RR station with a narrow field railway track laid between the Soviet gauge track. The three existing cranes were not in operation.
- Power supply: Power was supplied through a power transmission line coming from the northwest.
- Security: The plant was guarded by soldiers.

Comment: The reported data on the aircraft engine repair plant cover the period up to September 1946 but have been confirmed by more recent information.
