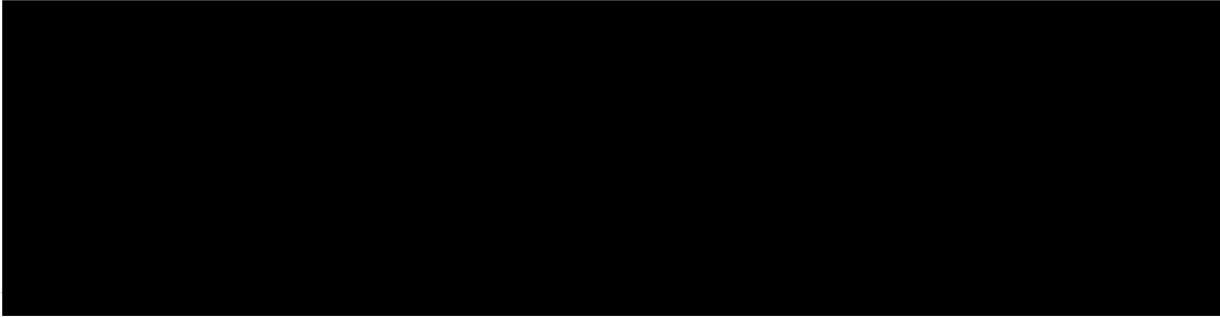

- 25X1X 1. Dr. Sumitro, who was the RIS Charge d'Affaires in the United States, until the Ambassador, Dr. Ali Sastroamidjojo, arrived in Washington, is now in Indonesia. He is trying frantically to make money by virtue of his position and is offering Chinese exporters in Djakarta his services if they take him into their firm as a silent partner and also put up all capital.
- 2. A. P. LIM* is representing Dr. Sumitro's interests in Singapore.

25X1A * [REDACTED] Comment. A. P. LIM is also known as LIM Aun Poon. [REDACTED] 25X1A
 May 1949, reported that LIM was a Java-born Chinese and was representing the American Indonesian Corporation. LIM is also believed to be involved in the smuggling of arms from Malaya to Indonesia. He has also been reported involved in the smuggling of narcotics.

25X1A [REDACTED] Comment. Most Indonesian officials appear to be trying to make a killing in business quickly at the expense of Government administration, which they are neglecting.
