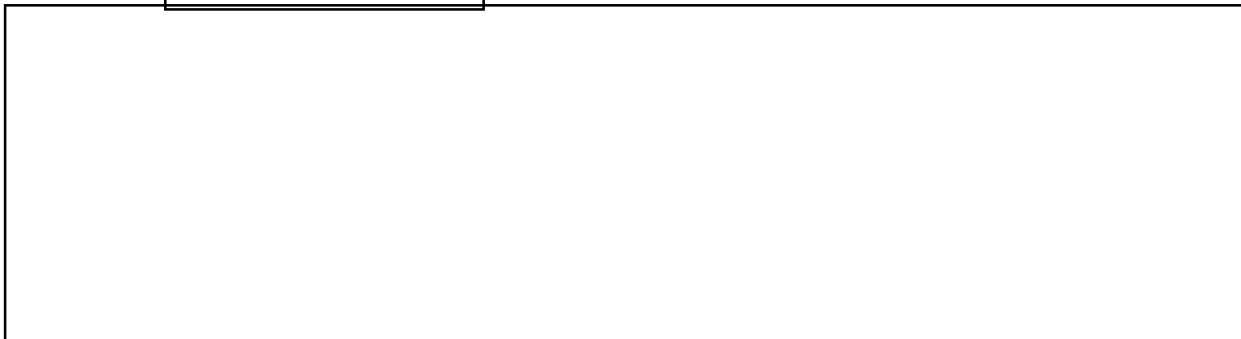

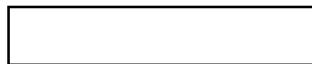

- Between 27 and 30 March 1950 CHOU Ta-k'ao (周大可), director of transport of the Chaoch'ing (112-29, 23-04) Military Control Commission (MCC), chartered four wooden boats of the West River type to transport two or three hundred cases of machinery and machine parts, in addition to other items, from Macao to Canton. A man named T'AN (譚) was in Macao, lodging in room 302 of the Wuchow Hotel, for the purpose of supervising the shipment and accompanying the boats to Canton. He held conferences with CH'IU (丘), a representative of the Canton MCC who is also connected with the Southern Trading Corporation\*. CH'IU was in Macao on a purchasing mission.
- On 28 March 1950, 100 cases of machinery and machine parts, and 200 cases of soybeans, red dates, paper, and medical supplies were loaded in Macao on a wooden ship. The goods were handled by the Southern Trading Corporation, and were to be shipped to Canton about 1 April 1950 for the Canton MCC.
- On 30 March 1950 four large wooden boats unloaded from the SS CHIAO T'UNG (交通), near Macao, approximately four thousand barrels of gasoline. Two thousand gallons (sic) were sent to a warehouse in Macao. The remainder of the gasoline was to be sent to Canton for the MCC, along with 200 cases of machinery and 5,000 sacks of soybeans, red dates, black dates, and paper.
- The Macao offices of the Southern Trading Corporation are on the ground floor of Dr. MO Lin's clinic in Pao Chang T'ang (報祥堂).
