- 1. The Northeastern Trading Company, also called the Dairen Import-Export Company, is believed to be the sole representative of the North China government Trade Bureau at Dairen.
- 2. It has the following affiliated firms in Hong Kong:

- a. Far East Enterprising Company, Inc. [Redacted] cable address FARESTENT (9314 in Chinese), 88 Connaught Road West, Hong Kong; manager, WONG. The firm owns SS ORIENTAL [Redacted], in Dairen on 9 August 1950, and is agent for SS BALEPIN, purchased in 1950 from the Ben Lines and anchored at B-2 Buoy in Kowloon Bay.
- b. China Mutual Trading Company, 15-21 Ice House Street, telephone 37816. [Redacted]
- c. China Resources Company, room 6, fifth floor, Pedder Building, Hong Kong. [Redacted]
