1. [redacted] over 300 Soviet-trained Chinese technicians arrived at Ch'angch'un (125-29, 43-53) to establish a chemical warfare school and research laboratory. The Soviets provided large quantities of reading and instructional material and over 100 tons of various types of incendiary apparatus.*
