- 1. A confidential note written by one MRG Chia-change, allegedly Indochinese representative of the People's Democracy of Viet Minh (sic), was sent from Vienna to the "Decurity League" of No Chi Minh via the representative of the No Chi Minh Government in Dangkok. The note was written in German and dated 10 September 1950.
- 2. The note contained the following statements:
 - a) "Tiltery circles are insisting here that only the successful outcome of the operations we contemplate will save Korea and will diminish the pressure of the Americans on the democratic troops."
 - b) "Furthermore, it will reveal the real intentions of the British and Americans towards China."
 - c) "is soon as the landing begin, I shall leave and will be in Canton between 10 and 15 October."
 - ** Machington Comment. There is no information available concerning the presence in Central Europe of a Viet Minh representative by this name or its Vietnamese equivalent. The present Chinese Communist Ambassador to the Soviet Union is AMIC Chia-chiang. It is possible that he is the individual listed as author of this note. The reference to the "Security League" of No Chi inh may have some connection with the establishment and activities of a Chinese Communist International Political Security Dureau (IPSD) which has been reported, but the existence of which has never been definitely established.

 Concerning the IPSD and its activities has also reported that AMIC Chia-chiang as active in the early stages of the formation of the IPSD and that his brother, AMIC Chia-chen, was, as of Wovember 1949, head of the Poreign Affairs Department of the Hong Mong branch of the IPSD.
