25X1A **Comment.** The items of equipment to be used for converted boxcars were ordered to be on hand by the Soviet Control Commission. **25X1A**
 Except for nails and candles, none of the items listed in the tabulation should have been used. The volume of items is excessive. If the use of these items continues at this excessive rate, their replacement is bound to cause great difficulties. Most of the missing items are believed to have been stolen by Soviet soldiers who traveled on the railroad cars concerned. The figures contained in the column Required Stocks were copied from a decree of the Directorate General, Railroads, dated 25 April 1950. **25X1A**
