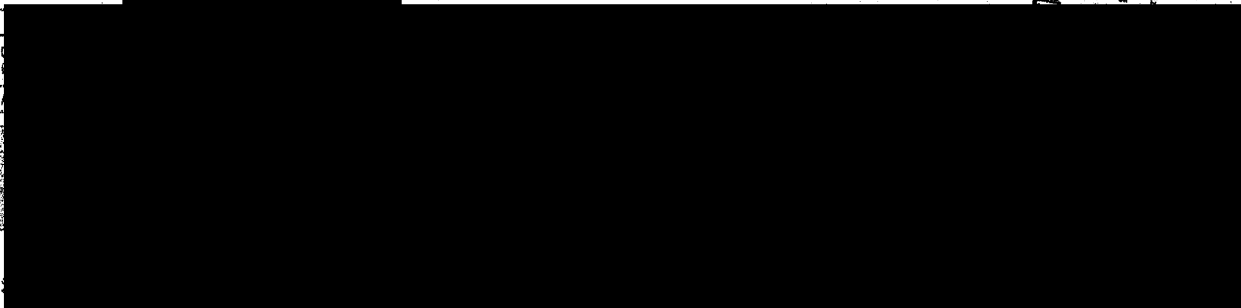

1. The Area Tobacco Directorate in Rijeka is under the administration of a board of directors which comprises a chairman and seven members. Egidio Bratolic is chairman of this board of directors.
2. The board of directors is responsible to the Workers' Council of the Tobacco Enterprise for its activities. This Workers' Council, composed of 15 members besides the president and vice-president, is elected by the workers. Ivo Tomljenovic is president of the workers' Council and Egidio Bratolic is vice-president.
3. Administrative personnel of the Area Tobacco Directorate in Rijeka is as follows:
 - a. Director: Josip Krzainic, alleged Cominformist, Communist Party member, and former Partisan. He was formerly a shoemaker in Klana in Bosnia.
 - b. Secretary: Viktor Sterpir, former member of the Domobran.
 - c. Chief of Personnel: Miroslav Skracic, who is also secretary of the Communist Party cell in the Directorate and UDB official.
 - d. Administrator: Antica Dragovic.
 - e. Chief of Commercial Division: Ivan Radotic, former Domobran officer.
 - f. Chief of Tobacco Processing Division: Edvard Kovacic.
 - g. Head of Accounting Division: Branislav Dzeba, former NDH (Independent Croatia State) radio announcer in Sarajevo, who spent two years in prison after the war.
 - h. Cashier: Neda Galinovic whose husband is a former Italian officer.
 - i. Bookkeeper: Rudi Zencner, who has optioned in favor of Italy.
