In approving the subject statement, circulated as an attachment to the reference, USIB agreed that the exception granted COMUSMACV "will be reviewed annually, or if circumstances dictate, at lesser intervals by the United States Intelligence Board, to determine that the exception is still required."

2. The Director, Defense Intelligence Agency, in the attached memorandum, states that the exception is still required and recommends that USIB reaffirm such exception for the duration of hostilities in Vietnam.
