

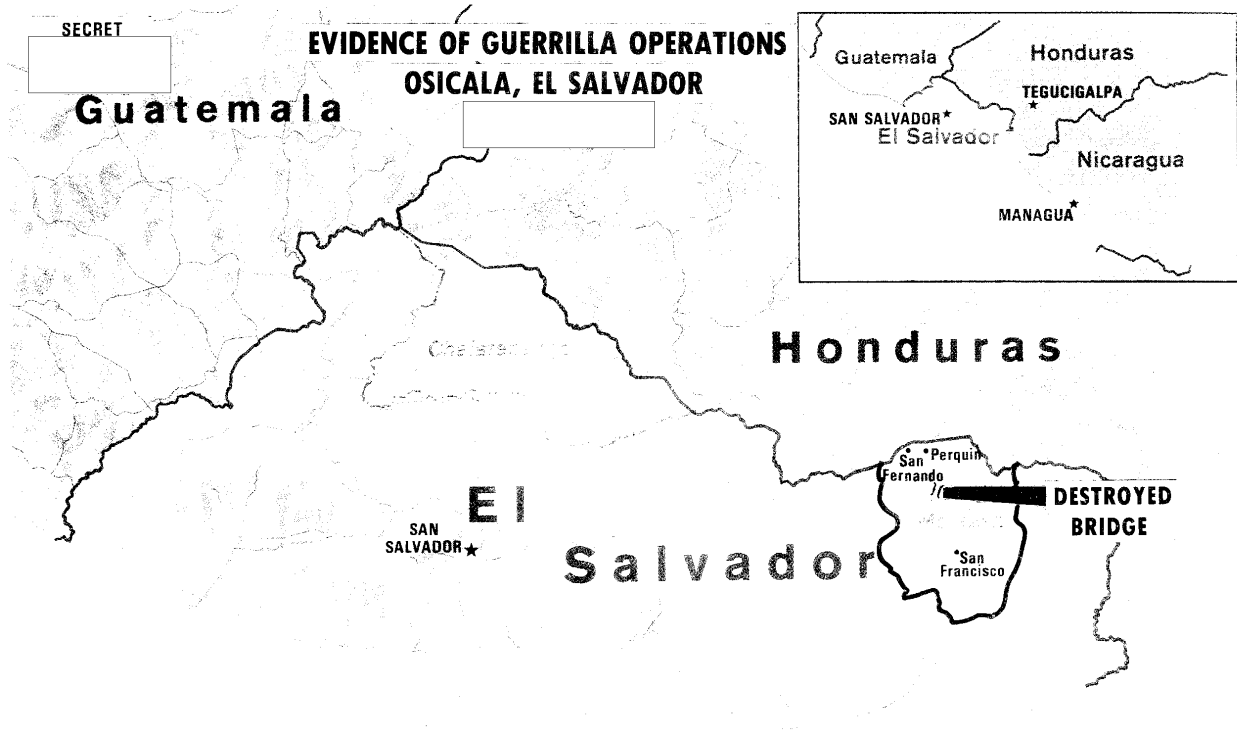

EVIDENCE OF GUERRILLA OPERATIONS
OSICALA, EL SALVADOR

1. (S/D) SIGNIFICANCE: DESTRUCTION OF THIS BRIDGE IN MORAZAN PROVINCE PROVIDES CONTINUED EVIDENCE OF ANTIGOVERNMENT GUERRILLA ACTIVITY (GRAPHIC 1 OF 2).
2. (S/D) REMARKS: TODAY'S IMAGERY CONFIRMS THAT ANTIGOVERNMENT GUERRILLA FORCES HAVE DESTROYED THE BRIDGE ACROSS THE RIO TOROLA RIVER (GRAPHIC 2 OF 2), 3 NM NORTH OF OSICALA. THIS BRIDGE IS BETWEEN THE TOWNS OF SAN FRANCISCO (A GOVERNMENT STAGING AREA), AND PERQUIN AND SAN FERNANDO, TWO TOWNS THAT GOVERNMENT FORCES ARE REPORTEDLY REENTERING AFTER THREE WEEKS OF OCCUPATION BY THE INSURGENTS. NO COMBAT OPERATIONS OR MILITARY FORCES ARE OBSERVED IN THE PERQUIN AND SAN FRANCISCO AREAS.

(S/D) THERE ARE NO INDICATIONS THAT EQUIPMENT OR UNITS ARE FORDING THE RIVER IN THE IMMEDIATE VICINITY OF THE BRIDGE, BUT GOVERNMENT FORCES APPEAR TO BE STILL PRESENT SINCE THREE TRUCKS AND ONE VEHICLE ARE NEAR THE SOUTH END OF THE BRIDGE.
