1. Auto Hall S A is an import house dealing in automobiles and agricultural equipment. They are local distributors for Ford and Mercury cars.
2. They occupy an imposing three-story stucco-brick building that covers an entire city block near the center of the city and have five branches in smaller communities in Morocco. It is a modern building with ramps to the two upper floors and basement.
3. The President and principal owner is Pierre Grand, a Frenchman, who has been in Morocco for 40 years. He is an energetic, able administrator. The other principal owner is G Meslin, who is Treasurer. The two men own all but a few shares of stock held by local friends.
4. There is a fairly well equipped machine shop in the basement, established principally for service of motor vehicles sold. Due to shortage of dollars, they have been unable to import pumps from the US which they have sold for several years. They have been able to purchase suitable castings locally and make about half the necessary parts, importing the balance from the US. The materials and workmanship are very good.
