SUBJECT: FPM Letter No. 736-4 -- Full Field Investigations on Competitive Service Employees and Applicants for Critical-Sensitive Positions

1. By the attached memorandum, the Deputy Director for Support refers to the recent FPM Letter No. 736-4 (copy attached) applicable to most Federal agencies with the view of determining whether our policies, practices and procedures conflict in any way with the requirements under this Letter.

2. The DDS specifically asks us to formalize any adjustments and exceptions in the investigative, polygraph and regulatory areas as they relate to the FPM Letter. I am asking each component concerned to look into this matter and furnish to the Executive Officer by 4 June 1969 a status report on actions you have or will take. A consolidated report will be submitted to the DDS.

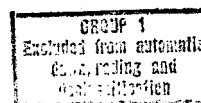

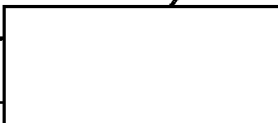
