SUBJECT : Citizenship Requirements for Agency
Staff Employment

1. The DD/A feels that HR [REDACTED] should be appropriately amended, as has been suggested by the General Counsel. The regulations should be as specific as possible, covering the point made by the Director of Security, that exceptions may be considered or granted when the Office of Security is able to conduct a valid background investigation on the applicant, and there are no other disqualifying factors.
