NFAC Responsibility for Indications and Warning

After having discussed the NFAC role in Warning with principal interested officers in NFAC, I would, in brief, make the following points:

--NFAC and the DDI have been involved in Indications and Warning in varying degrees since 1951. From 1951 to 1974 the Deputy Director of Central Intelligence or the Director of the Office of Current Intelligence (OCI) chaired the Watch Committee, which published weekly reports on the status of the world situation and those developments which posed potential imminent threat to US national security. In 1974 the Watch Committee was dissolved and the Strategic Warning Staff (SWS) created. This is a DCI staff which serves the Director's Special Assistant for Indications and Warning. (Until his transfer to EUCOM, this Special Assistant wa There is presently no Special Assistant. The NFAC has placed three analysts on the SWS.

--The formal Indications and Warning mechanisms of the National Intelligence Community, including the SWS, have focused on the key potential threats to US security such as the threat of Soviet attack, a North Korean attack or war in the Middle East. These warning topics are considered to be Warning (with a capital "W"). The rest of the warning problem (i.e., conflict in Africa) is considered to be "warning" (little "w") and are handled through special working groups as appropriate--for example, the present work on the Horn.

--NFAC is heavily involved in the study of the Indications and Warning problem. NFAC has heavy representation in the DIAsponsored Warning Improvement Study Program (WISP) which is currently the prime effort in the National Intelligence Community to develop methodologies and organizational structures to handle Indications and Warning and crisis management. NFAC is represented on all seven of the WISP subcommittees, and chairs two of them.

Considerable time and effort has been devoted to support of the WISP effort and NFAC has played a major role in developing the methodologies and indications lists for WISP.

-- The problem of NFAC's relationship to the NITC with regard to Indications and Warning is a subset of the larger problem a NFAC interface with NITC across the board. There is wide agreement that NFAC has a principal role in developing requirements and priorities for Indications and Warning and crisis management. There is less certainty about the degree to which NFAC should perform a day-to-day 'watch' function. My thought is that the Ops Center should be manned and trained to participate in that function with other centers--but not necessarily be prime to that function. NITC, of course, will be a critical component in the mechanism to control national intelligence collection during periods of crisis, but cannot play the leading role in the dayto-day "watch" function or the development of crisis management collection strategies.

-- The DCI has made clear his intentions to rationalize the Indications and Warning function within the National Intelligence Community. It is not yet clear what roles the various agencies would play. The Defense Intelligence Agency has, over the years, resisted efforts of the DCI to interpose himself between the military intelligence community and its principal consumer, the JCS. There is clear agreement, however, that NFAC has a major role in planning, overseeing and coordinating the Community Indications and Warning and crisis management function. The major issue remains to be the extent to which NFAC will be involved in the day-to-day Indications and Warning 'watch' function. There are varying views within the NFAC on what should be the formal NFAC responsibility for normal Indications and Warning "watch" operations. This, I believe, is a question for further discussion.

- 1. The last thorough examination of CIA procedures to provide intelligence support in the management of national crises was done by a Crisis Management Committee chaired by Cord Meyer, then Special Assistant to the DDCI. Two draft papers, Outline of Intelligence Community Actions During Crises and Checklist of Intelligence Community Action During Crises, produced by that committee are attached for your review.
- It is obvious that these papers need revision in light of the organizational and personnel changes since October, 1976. We have recommended to the DDC1 that an Agency or interagency group be convened soon to update our crisis management procedures.
- In the meantime, we must be prepared in the NFAC to proceed along the lines of the draft checklist of 6 October 1976. The principal change in procedures will require the substitution of ORPA for OCI when we consider the office responsible for organizing a CIA analytical task force.

SUBJECT

: Crisis Management

- 1. Crisis management is a topic that needs to be addressed soon from the standpoint of intelligence support to the President and cabinet officers in crisis situations. There is some ambiguity about the specific role of the DCI in those situations as well as the support he requires from the Intelligence Community and the Agency.
- 2. The attached papers (Outline of Intelligence Community Actions During Crises, draft 6 October 1976, and Checklist of Intelligence Community Action During Crises, draft 6 October 1976) are the result of careful deliberations by an Agency committee. But, my concern is that no further action has taken place since these draft papers were sent to the ODCI a year and a half ago.
- 3. My personal knowledge of what has been done to study this problem is, of course, limited by the short time I have been here. I did note that the last chairman of a committee to study this issue was a Special Assistant to the DDCI. My judgment is that the subject deserves your attention.
- 4. Some of the issues requiring discussion, if not immediate resolution are:
 - CIA task force arrangements to support DCI in crisis management situations
 - Interagency or National Task Force procedures to marshal Community resources in support of DCI -- and conflicts with departmental responsibilities
 - Role of National Intelligence Tasking Center
 - CIA relationship with State and Defense in either single agency or interagency task force

Subject: Crisis Manage

 CIA procedures to support DCI in PRC and SCC roles during crisis situations

- Procedures for moving from crisis management situations (Korea tree-cutting exercise, October War, evacuation from Beirut) to major emergency action procedures such as displacing intelligence support to follow President to alternate command sites.
- 5. We are reviewing our procedures in NFAC to follow the checklist of October, 1976, and I am confident that we can do a creditable job of providing support to you and the DCI in the event of a crisis. But, I will feel better about this after we have considered the roles of other elements of the Agency and the Community. My representative on this matter will be and he is available to provide you the background of the problem if you wish to discuss it.

SUBJECT

: Crisis Management

- 1. Jack Blake raised the subject of crisis management with the deputies to the DCI and then sent a memorandum containing Cord Meyer's draft procedures for Intelligence Community actions during crises. The memorandum served the purpose of reminding all of us that our draft procedures, which died on the NFIB agenda in 1976, were designed for an Agency and Community somewhat different than what we have in 1978.
- 2. In order to stimulate the DDCI to consider reviewing our crisis management procedures for the Agency and Community, the Director of NFAC sent Mr. Carlucci a brief memorandum on 6 February. It sketched a few issues and attached the 1976 draft procedures prepared by Cord Meyer. The NFAC office directors and NIOs also have received a copy of those procedures.
- 3. It is probable that the NFAC will be asked to submit changes to the 1976 draft procedures and to participate in a DDCI sponsored committee. In the meantime, NFAC must be prepared to organize task force support in the event of a crisis.
- 4. The attached revision of procedures is offered to you, Paul Walsh, Dick Lehman, and Vince Heyman for comment. My objective is to outline a procedure for Agency and Community task forces that we can use pending the DDCI review and decision. If we can strike a consensus among the five of us, I propose to use this as our NFAC guidelines and as an opening position in the DDCI forum.
- 5. Perhaps I could have your comments by 23 February and then we can determine if we are near a consensus.
