SUBJECT:

El Salvador

Within the next 30 days, the NSC will consider options for dealing with the war in El Salvador. Three papers are needed to support the discussion.

- 1. The DCI should take the lead in developing an assessment of the military situation in El Salvador.
- 2. The Department of State should prepare a paper assessing the nature of our interests in the outcome of the war and the political costs of a defeat in El Salvador. The paper should also examine the political options available for dealing with the war, and for rallying Allied and regional support.
- 3. The Secretary of Defense and the Chairman, JCS, should develop a paper outlining strategy options to defeat the insurgency and specific measures needed.

These papers should be completed by March 30.
