Later this year, the Committee on Rules, at the subcommittee level, will hold further hearings on proposals to improve congressional review of Federal programs. The legislation to be considered includes H.R. 2 and H.R. 58.

These hearings are a continuation of the Committee's efforts to develop procedures for comprehensive and coordinated oversight. The current budget reconciliation and reduction efforts point out the need for ongoing program review to provide better information about the performance of programs, and to enable committees to make informed choices.
