In making the announcement, League President Mortimer M. Caplin said, "This program, honoring ten top federal employees, offers fresh evidence of the quality and dedication of government employees. It also points up the range of challenging job opportunities found in government service. Not only do we honor the deserving, but we draw attention to the valuable contributions of government employees to our national well-being."

- Alan M. Lovelace, Director, Air Force Materials Laboratory, Air Force Systems Command, Department of the Air Force; for his creative competence in specialized chemical research, matched only by his managerial capability
