I urge you, however, to screen your employees carefully so that no qualified nominee is overlooked. Recipients of Honor and Merit Awards may also qualify for public recognition.

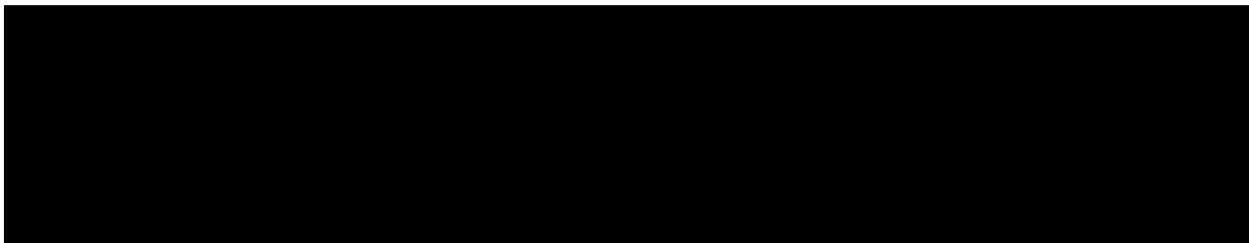

No. of Awards Granted: Six (Seven awards in 1968)

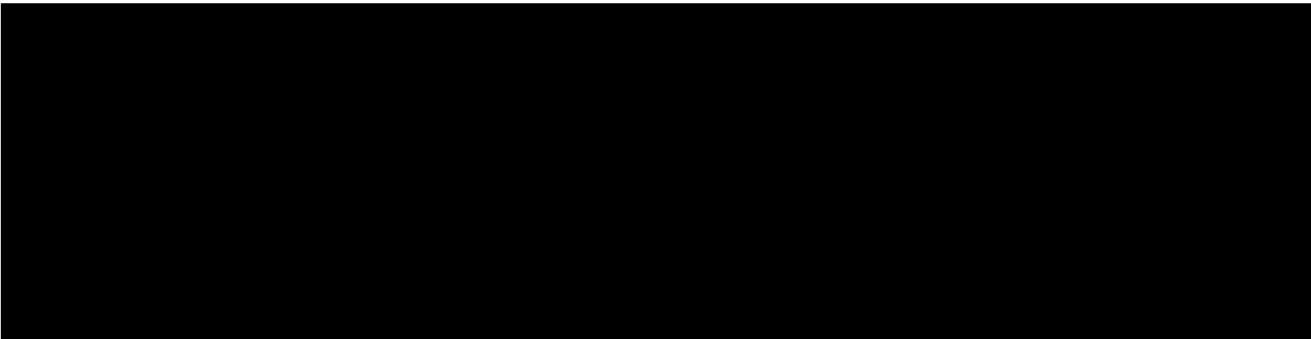
