1. (U) This memorandum is for information only.

2. (U) The activities of the Office of Security during the week of 2-8 September 1977 were highlighted by the following items:

a. (C) On 6 September two Office of Security polygraph examiners left for an extended TDY assignment in the Latin American area to service require-

b. (C) On 7 September two representatives of the Office of Security drilled open a safe located in the sub-basement of the Capitol. This action was taken at the request of the Director, Senate Office of Classified National Security Information, made through the Office of the Legislative Counsel (OLC).

c. (U/AIUO) On 8 September a representative of this Office conducted an inspection of storage facilities of the House Committee on Standards of Official Conduct. The inspection, also arranged by OLC as the contact point for dealings with the Congress, focused on physical security standards appropriate for storage of Agency material.

1. (U) This memorandum is for information only.
2. (U) The activities of the Office of Security during the week of 26 August-1 September 1977 were highlighted by the following items:
 - a. (C) On 29 and 30 August at the request of the Operations Directorate, Office representatives provided security [REDACTED] and his family.
 - b. (U/AIUO) On 31 August the DCI approved an industrial polygraph program to be implemented on a selective basis. A team of two Office of Security polygraph examiners will proceed to the West Coast during the week of 4 September to continue the polygraph interviewing of selective [REDACTED] personnel.
 - c. (U/AIUO) On 31 August the Office of Security expedited Sensitive Compartmented Information access approvals of staff officials of the newly established House Permanent Select Committee on Intelligence. The Committee's Sensitive Compartment Information storage facility was given security accreditation on the same day.
