2 - 8 August 1979

1. On 8 August, the Industrial Hygienist accompanied representatives of the Mail and Courier Branch, Office of Logistics, to the Phillips Company plant in New Jersey to inspect various x-ray devices. OL is in the process of selecting a new x-ray mail and package screening device. The Industrial Hygienist also went to the Baltimore-Washington International Airport on 2 August to inspect devices marketed by two other companies.

2. Members of the Safety Branch have been working with the Technical Security Division in an attempt to establish a training program in radiation safety for the engineers and technicians. Efforts are also underway to have a Radiation Safety Officer formally appointed and to have him attend additional specialized courses in radiation safety.

3. The Chief, Overseas Security Support Branch, briefed members of the SECOM R&D Subcommittee on results of the
