1. The Agency anticipates a reduction in operating funds for Fiscal Year 1965. Against the contingency that reductions may be necessary in the Support Directorate, I believe it would be wise for the Office of Communications to withhold the obligation of \$300 thousand for research and development and \$225 thousand in other items to be selected by you, or a total of \$525 thousand. The \$2 million in your Fiscal Year 1965 budget held for the DCI has been withdrawn and your budget should be adjusted downward by this amount.

2. For the present,	no other changes in your Fiscal Year 1965 budget
thus adjusted to	are necessary but your Fiscal Year 1965
allocation will be	reflecting a withholding of the \$525,000
discussed above.	

- 3. In accordance with previous agreements, your budget for Fiscal Year 1965 includes \$50 thousand in DD/S funds and your Fiscal Year 1966 budget includes \$80 thousand in DD/S funds.


