: Purple Heart Type Award for Civilians

- 1. As I mentioned last evening, there are three proposed actions regarding Purple Heart type awards for civilians in which both Mr. Bannerman and Colonel White are quite interested. As the DD/S Member of the Honor and Merit Awards Board, you may be interested in the attached papers on the subject. It seems likely that if the Department of State develops a special award for U. S. Government civilians injured in the course of their duties they will drop the effort to obtain authorization to grant the existing Purple Heart to civilians. I believe you mentioned that the Board proposes the establishment of our own Purple Heart type award regardless of action by the Department of State. If at a later date the Department does establish a new award we might want to look into its adoption in lieu of the special award which we may establish.
- 2. It will be appreciated if you will follow State Department action as well as Agency action and periodically advise Mr. Bannerman, who in turn will want to advise Colonel White of the progress being made.
