SUBJECT : Security Standards for Classified Plain
Text Distribution in Outside Buildings

1. Action Requested: Your approval of the attached proposed Security Standards for Classified Plain Text Distribution in Outside Buildings is requested.

2. Background: In July 1970 Security Standards for Headquarters Classified Plain Text Data Distribution Systems was published for the purpose of standardizing and controlling the installation of data circuits in Headquarters Building from a security standpoint. In many cases, these Standards have not been applicable in the Washington, D. C. area Agency buildings other than Headquarters; thus, the attached paper has been developed in cooperation with the Offices of Communications and Logistics.

3. Staff Position: The Offices of Security, Communications, and Logistics feel that more specific requirements are needed to address the different problems posed by distribution systems in outside buildings. The Offices concerned consider the attached proposed Standards to be an appropriate vehicle to address these problems.

4. Recommendation: It is recommended that you approve the attached Standards.
