The [redacted] Virginia, is presently under construction and is scheduled for completion in June - July 1981. Upon completion, the building will be leased by this Agency in accordance with authority delegated by the Administrator, GSA. A series of moves will begin at that time involving personnel in our Headquarters Building, as well as in leased space. The most significant of these moves affecting leased space will involve the

Agency components occupying approximately 37,000 square feet of space in the [redacted] will be moved to the [redacted] and an equivalent number of personnel will move from Headquarters [redacted]. We intend to utilize the [redacted] space "as is" to the greatest extent possible and to, thereby, keep costs to a minimum. Nevertheless, it is anticipated that needed alterations will be relatively extensive. At the same time, it is essential that these renovations be accomplished in a timely manner, immediately concurrent with the move to the [redacted]. Failure to do so would impact the entire sequence of moves, which affects more than 150,000 square feet of space in the Headquarters Building alone. Additionally, Fiscal Year 1981 funds have been budgeted for these renovations and, therefore, funds must be committed by year end.


