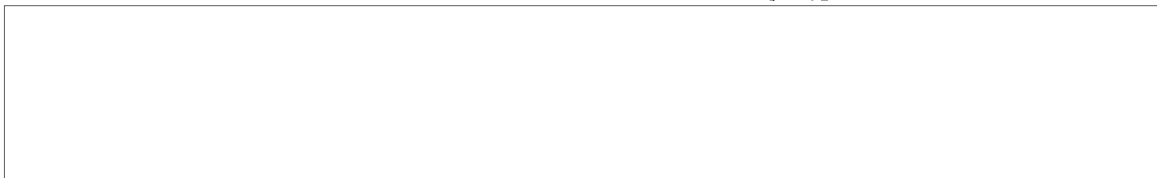

2. DEPARTMENT DELIVERED ODINGA ODINGA LETTER TO CONGRESSMAN WHITE'S STAFF. PAUL TSOMPANAS, A PROFESSIONAL STAFF MEMBER OF THE HOUSE ARMED SERVICES COMMITTEE, ON APRIL 29 AND SUGGESTED NO REPLY WAS NECESSARY. IN DOING SO DEPARTMENT PROVIDED BACKGROUND ON ODINGA ODINGA'S POSITION IN KENYA AND HIS ATTEMPTS, IN THIS CASE, TO EXPLOIT THE COMMITTEE'S PUBLIC REFERENCE TO THE RDJTF FOR DOMESTIC PURPOSES. TSOMPANAS AGREED ON BEHALF OF CONGRESSMAN WHITE WITH EMBASSY'S APPROACH REFTEL A - I.E. THAT EMBASSY ACKNOWLEDGE LETTER AND REFUTE ITS FALSE ALLEGATIONS OF U.S. BASES IN KENYA AT APPROPRIATE TIME.
