More specifically, the Board ruled that once it had nominated candidates for a program and the DDCI had approved the nominations, a candidate could not be withdrawn without formal notification to include the written approval of the DDCI.</p> <p>Therefore, the attached memorandum forwards for the approval of the DDCI the request that be withdrawn as the CIA's first alternate candidate for the 1981-82 Industrial College of the Armed Forces Program.</p>
