1. SIGNIFICANCE: THIS IS THE FIRST IDENTIFICATION OF STYX CRUISE MISSILE EQUIPMENT AT THIS ORDNANCE STORAGE FACILITY. (SWN)

2. REMARKS: A STYX CRUISE MISSILE AND ASSOCIATED STYX SUPPORT EQUIPMENT HAVE BEEN IDENTIFIED AT UIJU UP AMMO/ORDNANCE STORAGE FACILITY, IMMEDIATELY EAST OF UIJU AIRFIELD [REDACTED] STYX SUPPORT EQUIPMENT INCLUDING TWO STYX MISSILE TRANSPORTERS, TWO TRUCK-MOUNTED CRANES, AND AT LEAST FOUR UNIDENTIFIED VEHICLES HAD ARRIVED AT THE FACILITY BY JANUARY 1983. ON IMAGERY OF [REDACTED] A STYX CRUISE MISSILE WAS OBSERVED FOR THE FIRST TIME, REMOVED FROM ONE OF THREE SHIPPING CONTAINERS (INSET). THE THREE STYX SHIPPING CONTAINERS HAD ARRIVED IN THE STORAGE AREA BY MAY 1982. (SWN)

THE STORAGE FACILITIES CONSIST OF TWO LARGE AND TWO MEDIUM CONCRETE DRIVE-THROUGH STORAGE BUNKERS (ONE IN THE EARLY-STAGE OF CONSTRUCTION ON [REDACTED], TWO VEHICLE STORAGE BUILDINGS, THREE SUPPORT BUILDINGS, AND TWO CLEARINGS WHERE CRUISE MISSILE SUPPORT VEHICLES ARE PARKED. AN ADMINISTRATION, HOUSING, AND SUPPORT AREA IS IMMEDIATELY NORTH OF THE STORAGE AREA (NOT ON GRAPHIC). BUNKERS HAVE BEEN UNDER CONSTRUCTION IN THE STORAGE FACILITY SINCE AT LEAST SEPTEMBER 1981, AT WHICH TIME ONE OF THE DRIVE-THROUGH CONCRETE BUNKERS WITH A CLERESTORY ROOF SECTION WAS EXTERNALLY COMPLETE. THE BUNKER IS FENCE-SECURED AND MAY SERVE AS A CRUISE MISSILE MAINTENANCE/CHECKOUT BUILDING. (SWN)

THE REASON FOR STORAGE AND HANDLING OF STYX CRUISE MISSILES AT THIS FACILITY CANNOT BE EXPLAINED. TO DATE, NO DIRECT ASSOCIATION BETWEEN THE ORDNANCE STORAGE AREA AND THE AIRFIELD, WHICH SUPPORTS TWO BEAGLE (IL-28) BOMBER REGIMENTS, HAS BEEN MADE; HOWEVER, ROAD ACCESS TO THE STORAGE AREA PASSES THROUGH A PORTION OF THE AIRFIELD SUPPORT AREA, AND THE FACILITY

IS ROAD-CONNECTED TO ONE OF THE AIRCRAFT PARKING AREAS. NO INFORMATION IS AVAILABLE THAT WOULD INDICATE EITHER AN AIR, NAVAL, OR COASTAL DEFENSE USE FOR THE STYX CRUISE MISSILES STORED AT THIS LOCATION. UIJU IS 40 KM INLAND FROM KOREA'S NORTHERNMOST WEST COAST NAVAL BASE AT TASA RI. A NAVAL CRUISE MISSILE SUPPORT FACILITY IS COLLOCATED WITH THAT NAVAL BASE.
