MEMORANDUM FOR THE RECORD

SUBJECT: Jogging Trail

1. On 4 February 1980 I attended a meeting in the Office of C/LSD. In attendance were [redacted] of the Office of Logistics and [redacted] of the Office of Medical Services.

2. [redacted] indicated that he had done some estimating of cost for the one mile track, previously proposed by [redacted] which would roughly follow the inside of the perimeter fences of the athletic/recreation area. Two figures were given of estimated cost to build such a track. If the surface is gravel/cinder, the cost would be approximately \$25,000. If the surface is rubber/cork, the cost would be approximately \$35,000. [redacted] said he had looked at some physical fitness facilities of other agencies and wanted to explore installation of a commercial system in conjunction with the jogging trail which would involve planned exercise stations along the way.

3. The discussion then switched to the availability of two prefabricated buildings originally intended for [redacted]. Possibilities are that the building could provide not only showers and lockers for joggers but also new space for general exercising and physical fitness activities. A brief discussion of possible sites to locate the building then took place. [redacted] said that [redacted] would be consulted on this issue. [redacted] said that Mr. Wortman was to meet in [redacted] office the following morning to discuss plans in general for a physical fitness program. He said he would pass all of this information on and it was agreed that [redacted] should also attend.

[REDACTED] said this was pointed out to him when he toured the area and probably would require construction of a culvert since the proposed jogging trail would be located in the same area.
