1. In response to your communication of 2 February 1977, please be advised that the Special Security Center of the Office of Security meets with foreign liaison officers and security officials concerning security policies and procedures relating to the handling and utilization of Sensitive Compartmented Information (SCI) and/or technical collection sites or operations abroad. These contacts are generally confined to [REDACTED] representations. During the past nine months there have been two meetings,

Generally, these contacts are with liaison officers who have relationships with the DDI and/or the DDS&T, as well. There is no exchange of intelligence or operational discussion. The contacts deal strictly with security policies and procedures which may include some discussion of unauthorized disclosures of SCI material in the press. There is no formal training involved, but information and advice in compartmented security is provided as required. During the two meetings mentioned, [REDACTED] representative were permanently assigned to Washington. Both were accompanied by individuals visiting this area on a TDY basis.

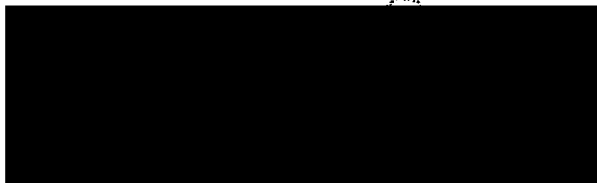

4. For your information the Chief, SIA was contacted telephonically and stated that he was concerned only with contacts with foreign liaison representatives permanently stationed in Washington, D. C. The Chief, SIA had no interest in official foreign visitors who were briefed in the United States while on TDY.

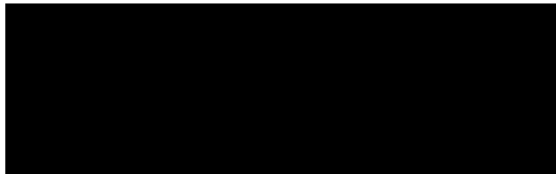
