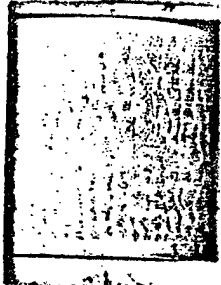

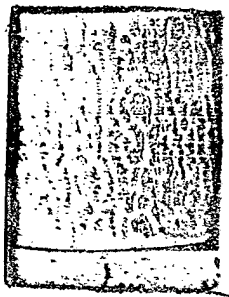

The Senate Committee has reviewed the reprogramming proposal described in the letter of November 9, 1982, under which the Agency would exercise the option to lease [Redacted] square feet of workspace in a building [Redacted]

We have no objection to this action. No more than [Redacted] in FY 1983 funds is to be used for this purpose and this amount is to totally satisfy all FY 1983 occupancy needs to include: rent, minor structural alterations, communications, and security.

The Committee is keenly aware of the severe overcrowding which now exists inside the Headquarters Building. Despite the lack of a FY 1983 appropriation, therefore, we believe obtaining the additional space identified is prudent and will have a positive influence on productivity. We expect to be notified of the sources you will select to offset the leasing costs promptly following the completion of Congressional action on the FY 1983 appropriation for the Central Intelligence Agency.
