ENDO STRESSED THAT THIS PACKAGE WAS DIFFICULT TO ARRIVE AT AND WAS POSSIBLE ONLY BECAUSE OF THE DIRECT AND PERSONAL INTERVENTION OF PRIME MINISTER NAKASONEL ENDO ALSO EMPHASIZED THAT A POSITIVE REACTION FROM USG OFFICIALS WOULD BE NECESSARY IF THE POSITION OF THOSE JAPANESE GOVERNMANT AND POLITICAL OFFICIALS SUPPORTING LIBERALIZING MEASURES IS NOT TO BE UNDERCUT. HE ALSO STRESSED THAT A POSITIVE REACTION FROM THE U.S. WOULD BE NECESSARY IF WE WERE TO EXPECT THE COORDINATING GROUP ON STANDARDS (PARA 3, D) AND THE OTO ADVISORY COUNCIL (PARA 3, C) TO ACT VIGOROUSLY AND EFFECTIVELY TO REMOVE IMPORT BARRIERS.

- THE JAN 13 PACKAGE CONSISTS OF THE FOLLOWING MAJOR COMPONENTS.
- A. TARIFF CUTS: TARIFFS WERE REDUCED OR ELIMINATED ON 47 AGRICULTURAL PRODUCTS, 28 MANUFACTURED PRODUCTS, TOBACCO ITEMS, CHOCOLATE, AND BISCUITS (DETAILS PREVIOUSLY REPORTED).
- QUOTA EXPANSION: QUOTAS WERE EXPANDED ON SIX AGRICULTURAL ITEMS INCLUDING BEANS, PEANUTS, FRUIT PUREE AND PASTE, NON-CITRUS FRUIT JUICE, AND TOMATO JUICE, KETCHUP, AND SAUCE.
- C. DTO: (1) ESTABLISHMENT OF A HIGH LEVEL OTO ADVISORY COUNCIL TO PROVIDE ADVISE AND SUGGESTIONS ON ALL ASPECTS OF OTO ACTIVITIES. (2) STRENGTHENING OTO BY IMPROVING AND SPEEDING PROCEDURES, AND ALLOWING I COMPLAINTS BY PROXY (I.E. EMBASSY OR CHAMBER OF COMMERCE ACTING ON BEHALF OF COMPANIES).
- D. IMPROVEMENT OF STANDARDS AND CERTIFICATIONS SYSTEMS: (1) A COORDINATING GROUP HEADED BY THE CHIEF CABINET SECRETARY AND COMPOSED OF CONCERNED MINISTRIES AND AGENCIES WILL BE ESTABLISHED TO REVIEW ALL STANDARDS AND CERTIFICATION SYSTEMS (ALL 37 LAWS) WITH A VIEW TO REVISION AND SIMPLIFICATION, INCLUDING AMENDING LAWS. E. IOBACCO: (1) EXPANSION OF THE NUMBER OF TOBACCO OUTLETS SELLING FOREIGN CIGARETTES WILL BE ACCELERATED. ALL OUTLETS THAT WISH TO IN ALL MAJOR METROPOLITAN AREAS, EXCEPT TOKYO AND OSAKA, MAY DO SO BY MARCH 31, 1983. BY OCTOBER 31, 1983, ALL OUTLETS IN TOKYO AND OSAKA WILL BE INCLUDED. ALL OUTLETS NATIONWIDE WILL BE ALLOWED TO SELL FOREIGN CIGARETTES BY THE END OF JFY '84 (INSTEAD OF END OF JFY '85).

6. COMMENT: THIS PACKAGE WAS DIFFICULT TO PUT TOGETHER, AND PM NAKASONE WAS PERSONALLY DIRECTLY INVOLVED. IT CONTAINS A NUMBER OF MEASURES OF BOTH IMMEDIATE AND POTENTIAL IMPORTANCE; MANY OF THE TARIFF CUTS ARE BENEFICIAL; A STRENGTHENED OTO AND A HIGH LEVEL REVIEW OF STANDARDS SYSTEMS IS POTENTIALLY MUCH MORE SIGNIFICANT.

- WE BELIEVE ENDO IS CORRECT IN ARGUING THAT A POSITIVE U.S. REACTION IS NECESSARY TO AVOID 11110NDERCUTTING SUPPORTERS OF LIBERALIZATION, AND TO HELP PROMOTE EFFECTIVE ACTION OF THE NEW OTO COUNCIL AND THE COURDINATING GROUP ON THE REVIEW OF STANDARDS SYSTEMS. CLEARLY, A POSITIVE REACTION TO A PACKAGE WITH WHICH NAKASONE IS PERSONALLY INVOLVED ON THE EVE OF HIS U.S. VISIT WOULD HELP SET A CONSTRUCTIVE TONE FOR HIS VISIT. TO AVOID SENDINGSTHE GOJ CONFLICTING SIGNALS, A COORDINATED REACTION WOULD BE USEFUL. THE ROAD TO
- WHERE WE NOW ARE HAS BEEN LONG AND DIFFICULT. WHILE WE HAVE NOT GOTTEN AS FAR AS WE MIGHT LIKE, OUR FIRST CONCERN MUST BE HOW TO GET CLOSER TO OUR GOAL OF A JAPANESE MARKET AS OPEN AS OUR OWN. WE CANNOT HOPE TO DO THIS IF WE DO NOT MAINTAIN THE PERSONAL SUPPORT AND INVOLVEMENT OF JAPANESE POLITICAL LEADERS WHO HAVE PUT
