Approval of Minutes

1. Action: The minutes of the meeting of 14 April 1952 (IAC-M-67) were approved with the amendment that the following should be substituted for paragraph 6:

"6. Action: Agreed to cancel this project as being no longer timely, and to substitute therefor an estimate of the effect upon our friends and allies of the Soviet attempt to promote a broad relaxation of tensions. Agreed also that the draft prepared by the National Estimates Board on this subject should be reviewed by the IAC representatives for early consideration by the IAC."

2. Action: Approved as revised and to include as an annex a copy of the chart presented by G-2 (with additions to be prepared by A-2) in its oral briefing on the Korean military situation.

4. Action: Agreed that the proposed estimate should be undertaken, with the understanding that Libya should also be included in order that the study might parallel the policy problem confronting the NSC Senior Staff.

Progress Report (IAC-PR-23)

5. Action: Agreed that the phrase, "before Mid-Year 1952," should be deleted from the title of NIE-40, "Potential Military, Economic and Scientific Accretions to the USSR Resulting from the Acquisition of Western Europe before Mid-1952," inasmuch as the data to be presented will be valid and useful for quite some time beyond mid-1952.
