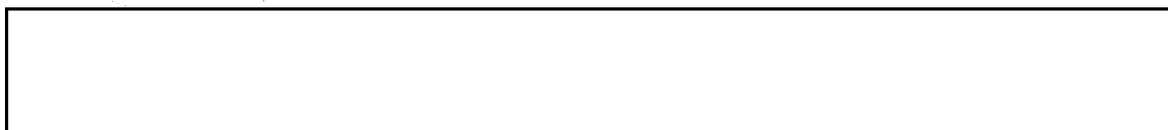

1. Action: Approved, subject to the addition of the word "current" in the last line of paragraph 8, so that the last sentence reads: "There was general agreement that, no matter what procedure is needed for conference participation, it should be so used as to insure no substantive difference between intelligence agreed at the conference and current IAC agreed intelligence."

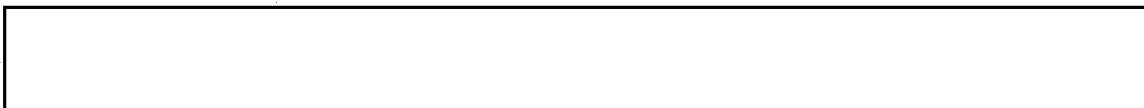
