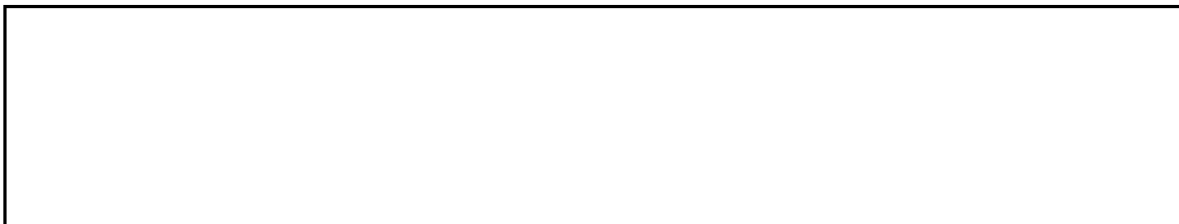

3. Post Mortem of NIE Production
for the Period 1 January to
30 June 1954

a. The IAC noted the paper after accepting an amendment by the AEC representative.

b. Mr. Armstrong raised the question of going beyond the scope of this paper by a review of the estimates made to determine their validity.

c. It was agreed that it would be worthwhile at least to experiment with such a review. As a preliminary, the Board of National Estimates was directed to make available to the IAC members its study of the validity of certain estimates prepared for the Clark Committee. 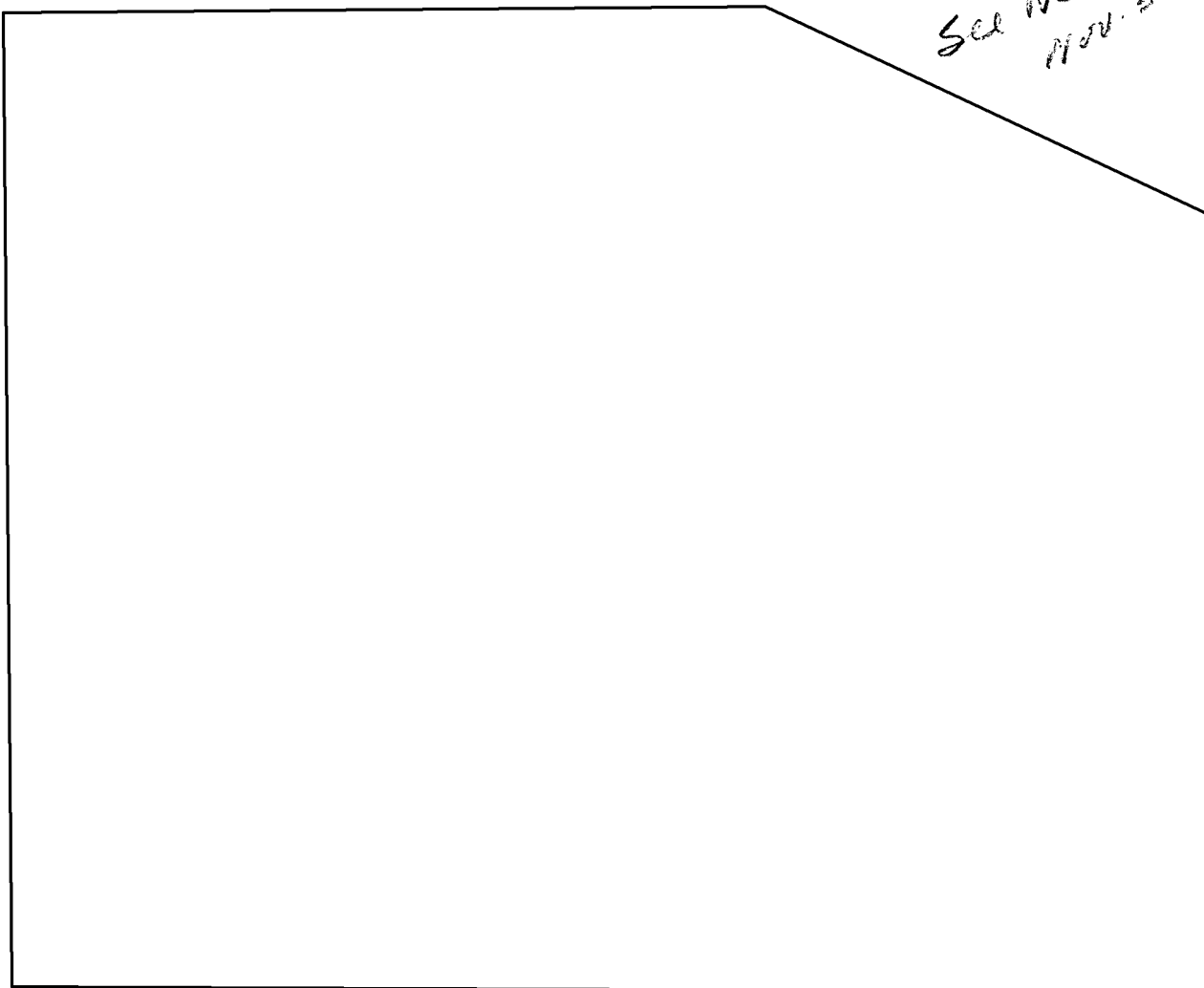

b. The Board of National Estimates was directed to consider the consequences of tightening controls as well as their relaxation.

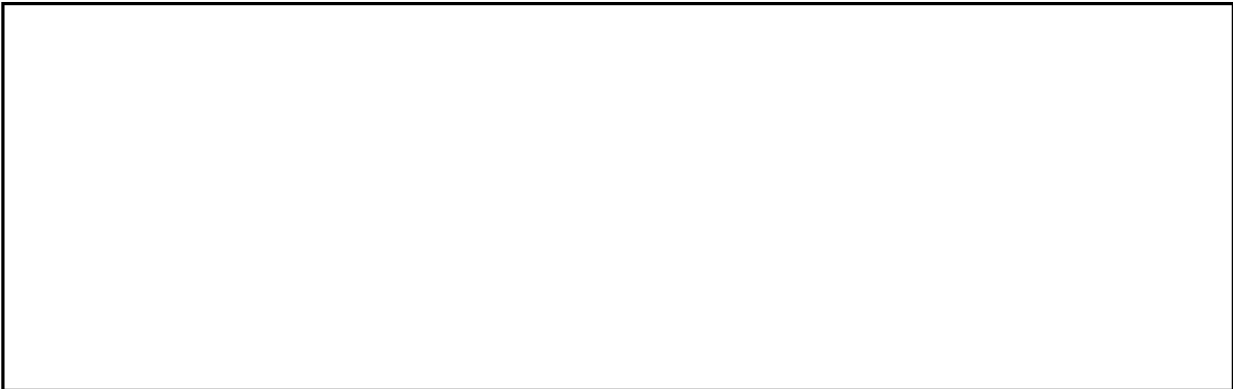
