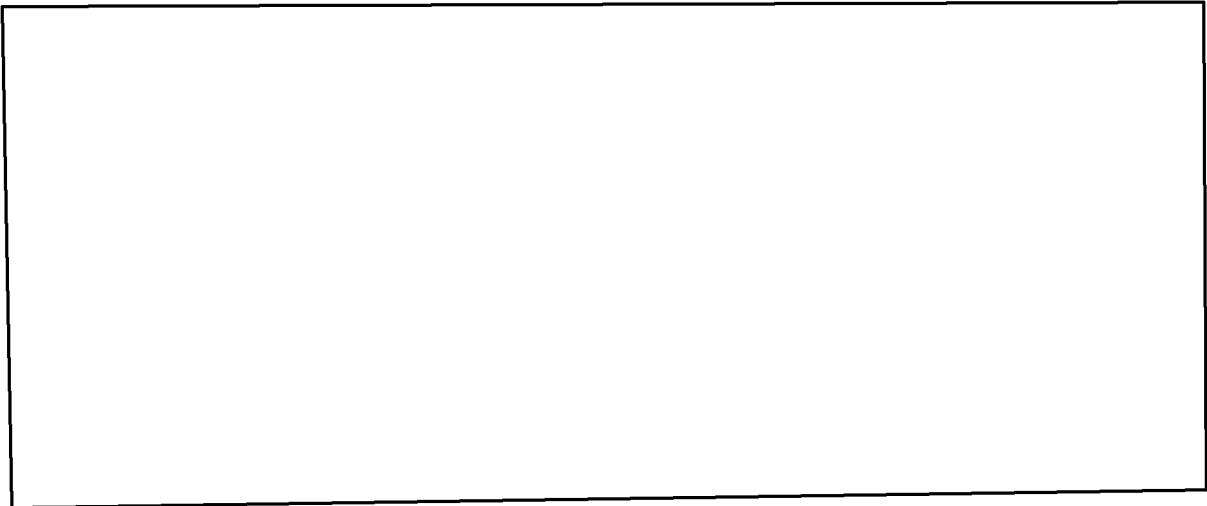

Conditions and Trends  
in Tropical Africa

a. Approved as amended.

b. Noted the findings, and approved the recommendations of the post-mortem on this estimate. In this connection, Mr. Dulles stressed the necessity of stepping up intelligence activities in this area. During the course of a discussion of this matter, Mr. Armstrong noted that the opening of four new foreign service posts should improve political reporting from this part of Africa, and General Schow referred to certain new activities which the Army was undertaking in Africa.
