Proposed Requirements Respecting Site and Building Plan

Submissions to the National Capital Planning Commission

The Commission, at its meeting on December 2, 1971, authorized the enclosed "Proposed Requirements Respecting Site and Building Plans" to be published as a Public Notice in the Federal Register on December 11, 1971. Interested agencies have been asked to comment on the proposed requirements within thirty days after their publication in the Federal Register.

The proposed requirements generally reflect the policies and practices of the Commission--and particularly those of the Federal Planning and the District Public Improvements Committees--that have been used for several years. However, several recent submissions have caused the Commission to question and seek clarification of these requirements which heretofore had not formally been adopted by the Commission as a whole.

We have enclosed a copy of the proposed requirements to afford you an opportunity to have your comments included in your agency's response to our Public Notice. The Commission will consider the adoption of the proposed requirements at its meeting on February 3, 1972.
