SUBJECT: Meeting with Assistant to the Executive Director-Comptroller

1. A section of the Inspector General Staff (Auditors) is located in the Key Building. Also the Historical Staff of the Director's office is located in the Key Building and the Magazine Building. Each of these elements consists primarily of office space with a small amount of special files. It, therefore, did not appear necessary for the Director's office, and the independent offices related thereto, to have a Building Planning Coordinator.

2. I discussed the above situation and the interests which the RPS had in overall Agency projections with I told him that in my opinion the PPB would be in an excellent position to provide guidance on trends which were developing in the various elements in the Agency and that, for this purpose and related RPS requirements, John Clarke, Director, PPB, had provided one of his officers as the PPB representative for this Staff whenever required.
