# WASHINGTON SEMINAR

May 15 - June 3, 1978

Make May 1978 a time for measurement — a month to assess the American presidency and the performance of an incumbent who will have been in office nearly a year and a half — a month to assess the legislative branch and the work of the 95th Congress which will be well into its second year.

The 1978 Washington Seminar will provide you with the yardstick, for your own measurements — a yardstick based on first hand interviews with the actual participants in the governing process — "President's Men" in the Administration, legislative leaders on Capitol Hill, lobbyists for major pressure groups, and journalists covering the Washington scene.

## 1978 THEMES

The major themes of the 1978 Washington Seminar will be: "The Carter Presidency: Promise or Performance?" and "The 95th Congress: Public Watchdog or Protector of Special Interests?"

## THE CARTER PRESIDENCY: PROMISE OR PERFORMANCE?

- Will the Carter Administration deliver?
  - An economic policy to control inflation and reduce unemployment?
  - A balanced budget by 1981 combined with more equitable taxation?
  - An energy policy to conserve resources and limit exploitation of consumers?
  - Streamlined administrative organization with improved public services?
  - A foreign policy based upon human rights — peace in the Mideast and justice in southern Africa?
  - Urban policies to reform welfare and rebuild the cities?

Will Jimmy Carter sustain the rhetoric of his campaign pledges and firestorm chats with a solid record of achievement? Will the "new boy in town" master the intricacies of the big time? Will the President be able to "get his act together" to forge an effective Executive Office staff — to reorganize and reinvigorate the administrative bureaucracy? Will President Carter shape a new dynamic presidency — restoring the charisma and imagery of "Camelot" in the eyes of a skeptical nation?

## THE 95TH CONGRESS: PUBLIC WATCHDOG OR PROTECTOR OF SPECIAL INTERESTS?

- Will the Congress of the United States act to:
  - Advise and not merely consent to foreign policy?
  - Screen the President's many programs — enacting only the positive?
  - Develop its own economic policy for stability, growth and equity?
  - Eliminate tax loopholes and favors for the few?
  - Pull together a fragmented administrative hierarchy?
  - Keep the Administration responsible to the American people?
- Will the House and Senate provide the necessary balance for a powerful presidency — enacting sound national proposals while holding to account a President of their own party? Will the two houses provide effective far-sighted leadership in the face of weakened party discipline and dispersed subcommittee power? Will the Congressional majority overcome the power of special interest alliances to protect the public interest?

## BASIC COURSE CREDIT

### Undergraduate Students

Undergraduate students will receive three hours of credit for successful completion of Political Science 401, Washington Seminar. Grading will be on the basis of: (1) the interviews conducted; (2) a "log," which both describes and analyzes selected interviews; (3) a comprehensive final examination. Course credit is transferable to other colleges and universities, subject to their regulations.

### Graduate Students

Graduate students will have the opportunity to write a paper in an area of their own interest, based upon their first-hand interviews and subsequent research. They will receive three hours of graduate credit for successful completion of Political Science 701 or Public Administration 701, Washington Seminar: Public Policy and Administration. Performance will be judged by: (1) the research paper (to be completed within a month after leaving Washington); (2) the interviews; (3) the analytical "log"; (4) the final examination. The course offers regular credit in the Maxwell School's master's and doctoral programs in political science and in public administration. Course credit is transferable to other graduate institutions, subject to their regulations.

## ADDITIONAL COURSE CREDIT

Undergraduate and graduate students who wish to undertake an independent research project for extra credit also may register for Political Science 490 or Public Administration 890, Independent Study. Each course may carry one, two or three hours of credit, thus enabling a student to take as many as six credit hours in the Washington Seminar.

**ELIGIBILITY AND ADMISSION**

While the Washington Seminar courses, both graduate and undergraduate, are conducted according to the usual high standards of the Maxwell School's Political Science and Public Administration departments, applications are encouraged from students majoring in other disciplines, as well as from those enrolled at other institutions. The only requirements are that students (1) must be in good academic standing and (2) must submit evidence of their intellectual and physical capacity to undertake an intensive, rigorous, and demanding program. Since the number of participants is limited by the nature of the program, early application is encouraged.

**PHYSICAL ARRANGEMENTS**

Housing arrangements are made by the Washington Seminar in order to assure convenience of location and the opportunity for close association among the participants. Charges for accommodations in a first-class Washington hotel will be modest—about \$9.00 per day for each of four persons in a family suite of two twin-bed rooms. Double and single rooms are available at proportionately higher prices. While meal charges obviously will vary according to individual tastes, excellent food is available at government and private cafeterias for an average daily cost of \$5.00. Cab fare (travel between interviews is normally by taxi) and other incidentals may be expected to average \$3.00 per day.

Payment for hotel accommodations and meals is the responsibility of the individual student. Hotel bills are normally paid weekly directly to the hotel. A facilities charge, not expected to exceed \$25, is payable at time of registration in Washington.

Travel arrangements to and from Washington are the responsibility of the individual student. Sometimes it may be possible to arrange car pools for sharing driving expenses.

Since the schedule of interviews and studies is intensive for the three weeks of the program, those who wish to visit Washington's many cultural and historical attractions should plan their sightseeing for the weekend prior to or immediately following the seminar.

**APPLICATION**

To apply for the Washington Seminar, fill out and submit the enclosed application form; please note that the names of the two persons you request to send letters of recommendation to the Seminar Office should be entered on the last two lines of the form. A registration fee of \$30 must accompany the application; this is credited against tuition (or may be refunded upon withdrawal prior to April 20, 1978). The tuition balance is payable not later than May 5, 1978. Checks for both the registration fee and the balance should be made payable to Syracuse University and submitted to the Program Director (address below).


