1. The SIG-I met on 27 April 1984 to address the hostile presence recommendations from the 1983 national hostile threat assessment and counter-measures report. [redacted]

2. At our suggestion, the DCI decided to scrub the four proposed recommendations and instead take the position as shown in the attached talking paper. This approach was supported by State, FBI, and DoD. Judge Webster did request, however, that the SIG-I obtain Presidential blessing on the principle of reciprocity. The DCI accepted this and ran it by Ken Dam, State, who also agreed. Judge Webster believed this would obtain a more cooperative effort from all the players in working out some viable options with which all could agree. [redacted]
