MEMORANDUM FOR THE NATIONAL SECURITY COUNCIL

SUBJECT: Security Clearance for Access
to Classified Information

Pursuant to NSC Action No. 2215-c, the NSC Planning Board has reviewed the draft Executive Order on the subject which was adopted by the National Security Council (Reference A) and approved by the President (Reference B), but which was not issued as an Executive Order. The Planning Board has ascertained that the regulations contained in the draft Executive Order are clearly superseded by subsequent Executive Orders, and accordingly recommends that the draft Executive Order be rescinded.

It is requested that each member of the National Security Council, the Secretary of the Treasury, the Attorney General, the Secretary of Commerce, the Director, Bureau of the Budget, and the Chairman, Atomic Energy Commission, indicate his action with respect to the above recommendation by completing and returning the enclosed memorandum form, if possible by or before Friday, December 23, 1960.*
