

PROPOSED CHANGE NO. 1

An editorial change. Proposed to replace E.O. 11905 with E.O. 12036.

PROPOSED CHANGE NO. 2

Paragraph 4:

Insert - "A TOP SECRET security clearance is a prerequisite for nominees for SCI access."

PROPOSED CHANGE NO. 3

Paragraph 5b(1):

Add "cohabitant" to the definition of "immediate family."

PROPOSED CHANGE NO. 4

Paragraph 6:

A reorganization of material and editorial changes plus continuation of proposal for use of polygraph (to be addressed later).

PROPOSED CHANGE NO. 5

Paragraph 10j:

Proposal reduces period of "less than 5 years overseas residence on US government business" to 1 year.

PROPOSED CHANGE NO. 6

Paragraph 10k:

Editorial changes.

PROPOSED CHANGE NO. 7

Paragraph 10.1.:

- a. "Cohabitant" is added to individual's spouse as requiring check through the subversive
- b. "and criminal" (added) files.
- c. The phrase "other persons to whom the individual is bound by affection or obligation" is added.
- d. A reference to "Annex A," Adjudication Guide, is added.

PROPOSED CHANGE NO. 8

Paragraph 10:

Add new section n as follows:

"All nominees for access to SCI shall be interviewed by trained security personnel utilizing the polygraph (See Annex C)."

PROPOSED CHANGE NO. 9

Paragraph 11 (old Paragraph 6):

- a. Some editorial changes.
- b. Adds to the requirement for a personnel interview by changing "should" to "shall" and adds the phrase "utilizing the polygraph (See Annex C)."

PROPOSED CHANGE NO. 10

Paragraph 12:

- a. Adds a requirement for polygraph to a requirement for review of personnel and security files where last BI is less than 5 years old.
- b. Proposes a polygraph in addition to BI where more than 5 years old.

PROPOSED CHANGE NO. 11

Paragraph 14:

Drops requirements for reinvestigation details and calls for a polygraph, up-to-date PHS and appropriate releases.

PROPOSED CHANGE NO. 12

Paragraphs 16 and 17:

- a. Editorial change--"investigate" to "investigative."
- b. Adds a requirement for use of Minimum Standards for Security Awareness Programs and proposes these be attached as fourth Annex to DCID.
