Subject: Department of Justice Attendance at
SECOM Subcommittee Meetings.

In recent months, some Department of Justice (DOJ) representatives to SECOM subcommittees have been unable to attend scheduled meetings, or arrange for substitutes. This has been due to our responsibility to the Courts in providing security assistance to Federal Judges presiding over cases involving national security information. These cases have required a significant amount of travel by my supervisory security specialists and have exhausted my personnel resources, therefore, I have been unable to provide the staffing to fully participate on SECOM Subcommittees.

Subcommittee members, although unable to attend scheduled meetings, are keeping abreast of the SECOM issues through the careful review of subcommittee minutes. Additionally, I am in the process of training several personnel to assist in the court security program. This will result in staffing adjustments to ensure DOJ attendance at all SECOM subcommittee meetings.

Your patience regarding this matter is appreciated.

The DCI Security Committee (SECOM) is responsible to the Director of Central Intelligence (DCI) for addressing the major security issues of concern to the Intelligence Community. It is comprised of a Chairman appointed by the DCI and 13 members who are the principal security officers of the Intelligence Community departments and agencies. It meets monthly or more often at the call of the Chairman. SECOM's organization and membership are shown on Attachment 1.

SECOM is chartered by DCI Directive to assist the DCI in establishing common security and access standards for managing and handling foreign intelligence systems, information and products and to ensure development of programs to protect intelligence sources, methods and analytical products. It advises the DCI on personnel, physical and information security, technical surveillance countermeasures, automated data processing systems, security education and security research and development.

The SECOM is structured to function through nine subcommittees and working groups, along with six subordinate panels and groups in the technical countermeasures and research and development disciplines. The subcommittee structure is shown on Attachment 2. Their functions are as follows:

1. Computer Security Subcommittee - Chaired by DIA. Reviews, develops and coordinates Community security policy for the protection of intelligence processed by or stored in ADP systems.

2. Compartmentation Subcommittee - Chaired by Air Force. Reviews, develops and coordinates security policy and procedures on the handling and use of sensitive compartmented information and data relating to intelligence sources and methods.

3. Personnel Security Subcommittee - Chaired by CIA.

Reviews, develops and coordinates Community security policy and procedures for the investigation and adjudication of the eligibility of persons proposed for access to sensitive intelligence. This subcommittee conducts seminars for Community personnel security officers who adjudicate investigative data for SCI access determinations.

4. Physical Security Working Group - Chaired by Navy.

A new working group established in May 1983, PSWG reviews, develops and coordinates physical security policy for the protection of Sensitive Compartmented Information. It supports physical security research and development activities of broad Community application. The organization also conducts seminars for officers responsible for implementing physical security policy.

5. Technical Surveillance Countermeasures Subcommittee -

Chaired by CIA. Coordinates U. S. Government defenses against hostile technical surveillance and conducts training for all Community personnel who conduct technical countermeasures inspections. Its Audio Countermeasures Working group develops uniform procedural guides and reports on audio "finds," and is the Community vehicle for technical information exchange. The Interagency Training Center, with CIA as executive agency, and the Interagency Telephone Laboratory, with FBI as executive agency, are funded and staffed by the executive agencies with assistance from the rest of the participating TSCS member agencies.

25X1 6. Security Advisory Group-USSR - Chaired by State. Plans and coordinates Community support for the State Department program to safeguard the new U. S. Embassy being constructed in Moscow. The SAG-USSR arranges support for the security inspection of Soviet-made and installed building components and for security measures to protect sensitive U.S. components being installed in the new building.

25X1 7. Security Awareness Subcommittee - Chaired by NSA. Develops and coordinates security awareness and education materials for use by the Community in briefing on the hostile threat and on measures to avoid compromise. The subcommittee arranges for the development of security awareness briefings and materials and catalogs for the benefit of the Community security awareness materials developed by departments and agencies.

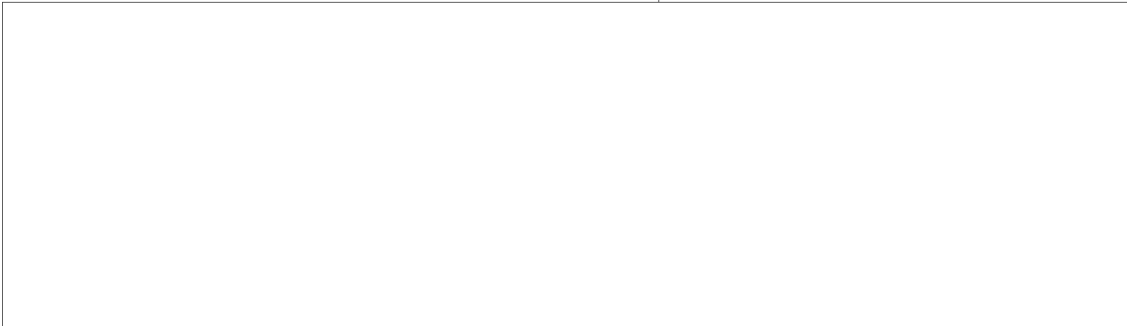
25X1 8. Unauthorized Disclosures Investigations Subcommittee - Chaired by CIA. Provides a focal point for the Community to coordinate investigations of unauthorized disclosures of intelligence, and seeks to develop security procedures to preclude the recurrence of leaks. The UDIS considers means to improve the quality, timeliness and Community coordination of leak investigations; and now is engaged in a study to more specifically identify the leak problem and possible solutions.

25X1 9. Research and Development Subcommittee - Chaired by CIA. Plans, coordinates and monitors research and development on matters

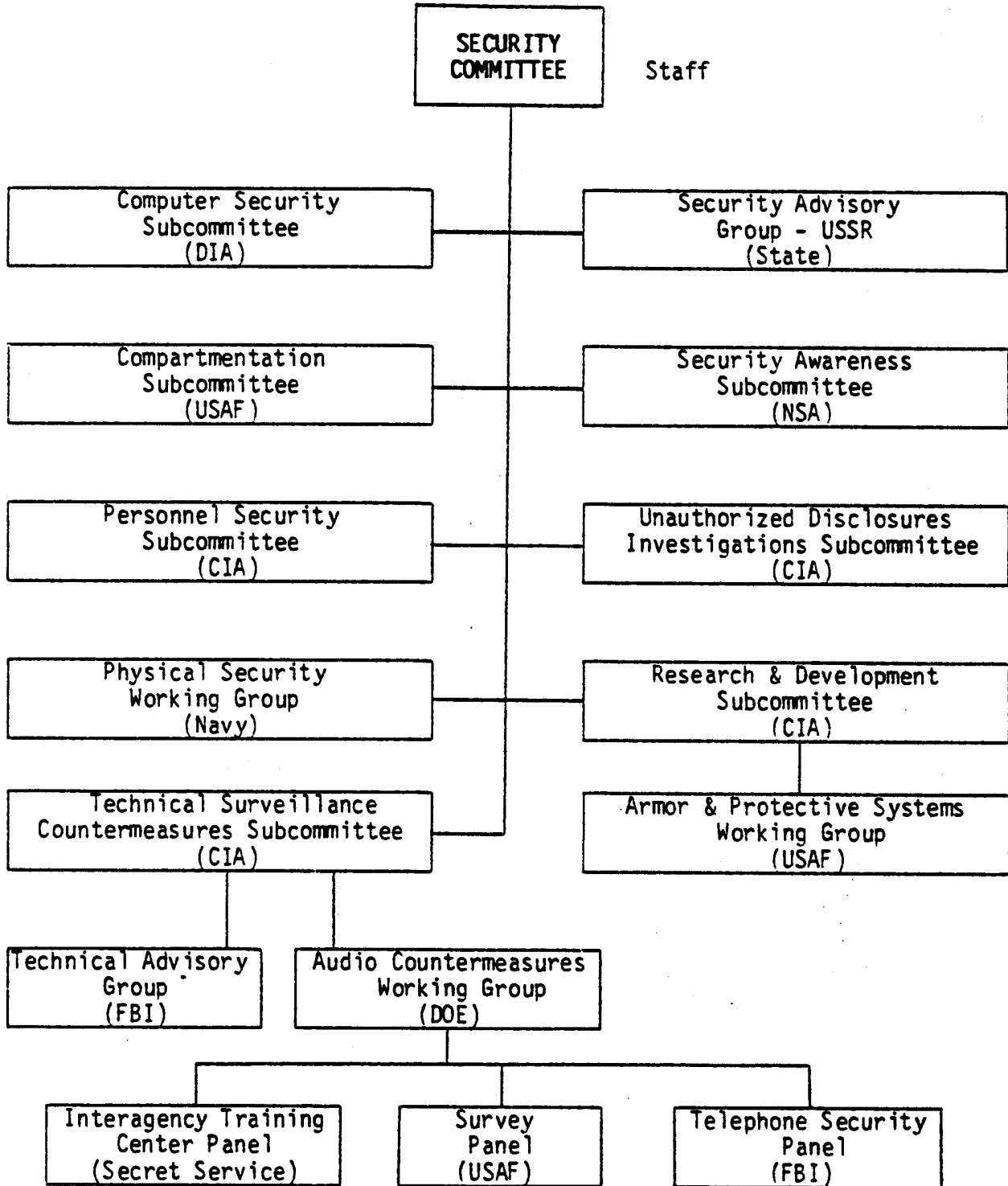

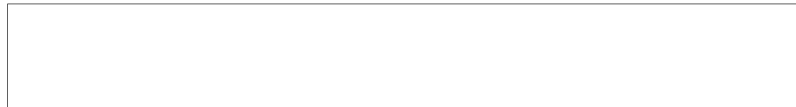
