The Subcommittee on Europe and the Middle East would like to have three short closed-session briefings with Agency officers early in the 99th Congress to provide background information on issues under the subcommittee's jurisdiction.

We would like to set up separate sessions on: the Middle East and Persian Gulf; The Soviet Union and Eastern Europe; and Western Europe. The purpose of these meetings would be to provide members with an overview assessment of key political, economic and military trends, likely problems and status of regional conflicts.
