Copies of the Executive Director's Recommendation on any action item on the agenda for the FEBRUARY 7 meeting may be obtained from Mr. Frazier on or after FRIDAY, FEBRUARY 1.

Action items for which no organization or individual has advised Mr. Frazier by WEDNESDAY, JANUARY 30, 12:00 Noon, of a desire to present views in person to the Commission and on which the Executive Director recommends approval or a favorable report, may be placed on the "Consent Calendar" and acted upon by the Commission, without presentation or discussion, at the beginning of the Commission meeting on FEBRUARY 7.

Submission of written views on any item is welcomed up to the time of its consideration by the Commission. However, the Secretary to the Commission can insure that copies of written statements will be reproduced and distributed to each member of the Commission only if such statements are received by noon of the day preceding the day of the meeting.

Comments are solicited on all matters before the Commission. However, comments on non-Federal plans and projects should be limited to their effect on Federal interests in the National Capital Region.
