Gentlemen:

1. This document constitutes Amendment No. 6 to Contract No. HF-CT-699 between the parties hereto effective for the period 1 November 1958 through 30 June 1960 and amends said contract, as amended, as hereinafter set forth.

2. Pursuant to the provisions of paragraph (b) of PART V - PERIOD OF PERFORMANCE of the Schedule, the period of performance of the contract is hereby extended for the period 1 July 1960 through 31 August 1960.

3. In accordance with PART VI - ESTABLISHMENT OF A PRICING FORMULA of the Schedule, the parties hereto have negotiated and agreed to the following Pricing Formulas for the periods indicated:

- APPENDIX II - Period 1 July 1959 through 31 December 1959
- APPENDIX III - Period 1 January 1960 through 30 June 1960
- APPENDIX IV - Period 1 July 1960 through 31 August 1960.

4. Paragraph (a) of PART VII - FUNDS ALLOTTED, as amended, of the Schedule is deleted and the following is substituted therefor:
