



## CIPC Organizational Activities

- Our primary focus this week has been:
  - preparation of the interim terrorism report for the DCI;
  - formulation of a task-force to address the DABM problem;
  - finalizing the Cruise missile report; and
  - finalizing the Narcotics report.
- Terrorism Report: The report has been forwarded to all working group members, CIPC principals and appropriate IC Staff elements for coordination by noon, 23 December.
  - Maximum effort is being exerted to get the report to the DCI early afternoon today community coordination is pouring in.
- Soviet Strategic Defenses -- DABM: Formulation of the ad hoc task force to prepare an interim report for the DCI is progressing smoothly.
