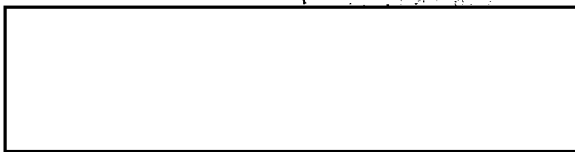

a. Any officer or employee who is on duty with the Agency and who is officially determined to be absent in a status of missing, missing in action, interned, illegally seized by another power, captured by an enemy, beleaguered or besieged, shall, for the period he is officially carried or determined to be in any such status, be entitled to receive or to have credited to his account the same pay and allowances to which he was entitled at the beginning of such period of absence or may become entitled thereafter, and entitlement to pay and allowances shall terminate upon the date of receipt by the ~~department~~ ^{Agency} concerned of evidence that the person is dead or upon the date of death prescribed or determined under provisions of this section:

PROVIDED, That such entitlement to pay and allowances shall not terminate upon expiration of term of service during absence and in case of death during absence shall not terminate earlier than the dates herein prescribed;

PROVIDED FURTHER, That there shall be no entitlement to pay and allowances for any period during which such person may be officially determined absent from his post of duty without authority and he shall be indebted to the Government for any payments from amounts credited to his account for such period.

1. The President has requested that there be submitted to him by 29 November any subject which agency heads wish to propose for inclusion in the President's State of the Union message. This should include a brief explanation of such subject and its relationship to the current activities and plans of the agency and the relative emphasis recommended.

2. Also to be included are any views which you may care to present for special Presidential messages in the coming Session.

3. It is not believed necessary to have the President include any material regarding proposed CIA legislation in his annual message, nor is it believed necessary that our proposed bill be forwarded with a special message.

4. In view of the above, it is felt that no action should be taken in this connection.
