- Q. Will you state your name, rank, home station and duty here?
- A. James L. Gaunt, Tech Gergent, Norton Air Force Base, 290hth Aircraft Repair Squadron
- Q. And your duty here?
- A. I guess it is crew chief in charge of the ground work.
- Q. That is turn around maintenance? Is that correct?
- A. Yes, sir.
- Q. When did you arrive here at Burbank?
- A. I came here the 15th of November.
- Q. was 9008 here when you arrayed?
- A. Yes, it was already here.
- Q. What type of maintenance do you do?
- A. Just regular aircraft maintenance. Maintenance general.
- Q. And you did some maintenance on the aircraft on the evening of the 16th?
- A. Yes, sir, we changed a primer solenoid.
- Q. Will you tell me what you do when you have write-ups on the radio equipment on the aircraft operating out of here?
- A. We have to go through Lockheed to get those people, the specialist, to do it, we don't know enything about it.
- Q. Since you have been here has 9065 had any radio difficulty?
- A. No, sir, not to my knowledge.
- Q. You wouldn't know about it if it had?

- A. Yes, sir, I would.
- Q. Po you know if the aircraft was equipped with search radar?
- A. No. sir I don't know for sure.
- Q. I understand that you had previously flown with the pilot, it Pappas, at your former duty station. Is that correct?
- A. Yes, sir it is.
- Q. Will you state when, where and what your duties were?
- A. I was Flight Engineer on C-47 down at Warner-Hobbins, Heorgia.
- Q. And for how long a period did you fly on his crew?
- A. I was just off and on. I flew with him several different times. Different dates, I am not sure, during part of '52 and first of '53.
- Q. You were not assigned as an integral crew?
- A. No, sir, I wasn't
- Were you present when the aircraft departed on the sorning of the 17th?
- A. Yes, sir, I was.
- Q. What time did he block out?
- A. Approximately seven o'clock. I wouldn't be for sure of the exact minute.
- Q. Did you observe the take-off?
- A. I was out there and watched part of it. I did not get to see all the take-off.
- Q. Was there anything out of the ordinary, or was everything normal?
- A. Everything was normal, sir.
- Q. Do you know snything about the activities of the crew on the evening of the loth?
- A. No, sir, I don't.
