SUBJECT: Address of the Association of Former Intelligence
Officers National Convention

1. This is background information for your address at the Association of Former Intelligence Officers (AFIO) National Convention on Saturday, 10 October, 10:30 a.m. - 12:00 noon, at the Tysons Corner Sheraton Hotel, 8661 Leesburg Pike, Route 7 and the Dulles Access Road. Phone: 448-1234.

2. Arrangements: You are asked to be at the main entrance of the Tysons Corner Sheraton Hotel at approximately 10:30 a.m. where you will be met by the Executive Director of AFIO, John Greaney, who will escort you to the Lord Fairfax Ballroom. Mr. Greaney will introduce you at 10:45 a.m. and you are scheduled to give 30 minutes of remarks. The suggested topic is the "Need for Cooperation between the Intelligence Community and the Academic community." After your address, Robert R. Simmons, an associate fellow at Berkeley College, Yale University, is scheduled to give 30 minutes of remarks on the role of the professor teaching a course on intelligence. Mr. Simmons was [redacted] [redacted] appointed Staff Director of the Senate Select Committee on Intelligence in 1981. (See biography and news articles opposite.) A 20-minute question and answer period moderated by John Greaney will follow. You will be seated on the dais at a table with Mr. Simmons and Mr. Greaney. Although a microphone will be located on the table, you are requested to give your remarks from the standing podium which will also have a microphone. Adjournment is at 12:00 noon.

Approximately 250 - 300 AFIO members, spouses, and guests will make up the audience. THE NEW YORK TIMES' investigative reporter Steven Engelberg, NEWSWEEK's national security reporter Richard Sandza, and Joe Trento formerly of the WILMINGTON NEWS will cover the event. You will recall that Mr. Trento took advantage of John Paisley's death and embellished on the story to keep it in the public eye and make it look as though it was something more than a suicide. Reporters Kate Coe and Mitchell Kross from Los Angeles TV station KCET will be taping the program along with ABC and CNN. DCI Security also will tape your remarks for the Agency's historical records.

Members of the AFIO Board of Directors will be present. (See letter head opposite for board members and officers.)

3. **Background:** The theme of the 1987 Convention will be "Counterintelligence". The topic will be explored from the perspective of a need for counterintelligence to meet the threat of the KGB. The specific topics which will be discussed include "Foreign Counterintelligence Outside the United States" as well as "Foreign Counterintelligence Inside the United States." The threat from domestic subversive groups and a wrap-up of the current reaction to the threat of foreign intelligence operations against the United States is also on the agenda. (For further information see PERISCOPE opposite.) General Richard Stilwell will be the luncheon speaker and General William Odom the banquet speaker.

Since your section of the program covers cooperation between the Intelligence Community and the academic community, you may wish to note that AFIO has an active Academic Assistance Program of providing books to professors who teach courses related to intelligence. At present AFIO is in contact with 100 professors and have sent the following books to them:

George C. Constantinides's Intelligence and Espionage : An Analytical Bibliography, Scott Breckinridge's The CIA and the U.S. Intelligence System, and Bibliography on Soviet Intelligence and Security Services by Raymond G. Rocca and John J. Dziak. The fourth book will be Breaking the Ring by John Barron and is scheduled for distribution this fall.

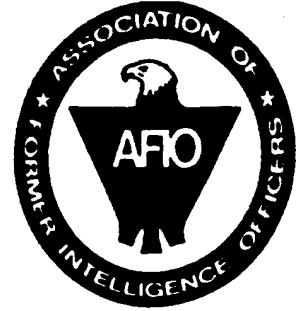

We are very pleased that you are able to accept AFIO's invitation to address our National Convention on Saturday, October 10, at 10:30 a.m. The Convention location this year is at the Tysons Corner Sheraton Hotel at Route 7 and the Dulles Access Road.

We would appreciate your addressing the topic similar to the way you spoke to the Harvard faculty about the need for cooperation between the Intelligence community and the Academic community. AFIO has engaged in an active Academic Assistance Program whereby we have provided books to professors who teach courses related to intelligence. At the present time we are in contact with 100 professors and have sent three books: George C. We have asked one of our members who teaches a course at Yale University, Robert R. Simmons, formerly the Staff Director of the Senate Select Committee on Intelligence, to offer some comments on the role of the professor teaching a course on intelligence. After Rob has concluded his remarks the two of you would respond to questions from the audience and/or comments regarding the other speaker's views.

Executive Director of the Association of Former Intelligence Officers (AFIO) John Greaney has invited you to introduce President Reagan at the convention banquet which will be held at the Tysons Corner Sheraton Hotel on Saturday, October 10th. At this point the President's attendance is still pending. If the President declines, Mr. Greaney has indicated that he wishes to invite you to be the keynote speaker. I made a commitment on your behalf for you to introduce the President, but made no promises for any other participation. The theme of this year's conference will be a testimonial by the Intelligence Community to the memory of Bill Casey. While I know you had fond feelings for Bill Casey, I think this would not be an appropriate time for you to address this group. I suggest that we look for a different occasion for you to address AFIO. You will recall that you did speak to AFIO's local chapter last December.

Since we do not have a firm invitation for you to be a keynote speaker, I want to have your agreement on my recommendation so that we can deflect the request. I would propose to tell AFIO that your heavy schedule in October precludes another major address, but that we would try to arrange something for a later date.




