Background: The D/NRO has provided a short status report on incorporation of the NRO Senior Advisory Planning Group (SAPG) recommendations in NRO planning but has provided no additional backup information. Comments and a recommended response were requested of Director, Intelligence Community Staff and Deputy Director for Science and Technology. The SAPG is an outside advisory body chaired by the former DDCI, John McMahon. It met during the first half of 1987 and provided its recommendations to the D/NRO in the second half of 1987. 3. Discussion: We have prepared a very short response that thanks the D/NRO, states our general agreement, and invites a continuing dialogue on those issues that remain unresolved. We have also prepared a very short point paper on the SAPG recommendations and actions taken. [redacted] 25X1


